WHEREAS, Jeff earned his Water Distribution Operator, Grade 2 certificate in December 2004, Collection System Maintenance, Grade 2 certificate in August 2013, and his Water Treatment Operator, Grade 2 certificate in June 2015; and

WHEREAS, he has brought vast knowledge of well operations that he learned from his previous employer, Floyd Wells Pump Service, and has passed it on to his co-workers. Jeff has an excellent attendance record, and can always be depended upon to respond to after-hours work and emergencies. He has earned the respect of Village residents and District employees; and

WHEREAS, Jeff has been instrumental in the design, installation, and operation of the Supervisory Control and Data Acquisition (SCADA) system and Automated Meter Reading (AMR) system. Jeff has worked closely with the District's SCADA and meter contractors to ensure successful operation of both systems; and

WHEREAS, Jeff has continually showed leadership in the field by taking the lead on the valve and hydrant replacement program, replacing Lift Stations 3 and 4, and day-to-day operations; and


