The \$125.00 deposit paid at the time of starting service will be credited to your account after 2 years of service or when you leave the District, whichever comes first. The \$45.55 advance sewer payment will be credited on your first bill, as shown below.

Your initial bill includes a prorated sewer service charge for this month plus a full sewer service charge for next month.
