RESOLUTION NO. 32

Resolution of Vandenberg Village Community Services District Requesting Representation of Independent Special Districts on the Local Agency Formation Commission of the County of Santa Barbara and Adoption of Rules and Regulations

WHEREAS, virtually all of Santa Barbara County, including all incorporated cities, is served by independent special districts; and

WHEREAS, a substantial amount of the work of the Santa Barbara County Local Agency Formation Commission (called "LAFCO" herein) involves or effects independent special districts; and

WHEREAS, independent special district representatives on LAFCO would contribute substantially to the process of planning to provide public services effectively and efficiently throughout the county and would broaden the prospective of LAFCO in planning and implementing orderly growth in our county.

NOW, THEREFORE, BE IT RESOLVED, by the Governing Board of Vandenberg Village Community Services District that this district is an independent special district, as defined in Section 56044 of the California Government Code, and is situated entirely within the County of Santa Barbara; and

BE IT FURTHER RESOLVED, that this Board hereby proposes representation of independent special districts on the Local Agency Formation Commission of the County of Santa Barbara; and

BE IT FURTHER RESOLVED, that this district hereby requests the adoption of rules and regulations, as provided for in Section 56451 of the California Government Code, and further requests that no regulations be adopted under Section 56451(d) that would prohibit, restrict, condition, or require LAFCO approval for, exercise of any powers of any independent special district; and

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to the Executive Officer of the Local Agency Formation Commission of Santa Barbara County.
