## **Resolution No. 154-02**

**March 5, 2002**

### **A RESOLUTION OF THE BOARD OF DIRECTORS OF THE VANDENBERG VILLAGE COMMUNITY SERVICES DISTRICT REAFFIRMING DISTRICT POLICY FOR MITIGATION OF GROUNDWATER CONSUMPTION BY NEW DEVELOPMENT**

WHEREAS, the Board of Directors on December 4, 1997, voted that the District should not allow additional connections which will increase net consumptive demands on the groundwater supply; and

WHEREAS, the District's policy for consideration of developer requests for issuance of Can and Will Serve Letters for Water and Wastewater Service requires developers to participate in some mechanism, acceptable to the District, intended to ensure that the project will not increase the District's net consumptive demand on groundwater; and

WHEREAS, the Lompoc Groundwater Basin from which the District pumps has been determined by the County of Santa Barbara to be in a condition of mild overdraft; and

WHEREAS, the District has no current plans for supplemental water supply; and

WHEREAS, The District has an interest in protecting the water supply of its current and future residents while working with other Lompoc Basin users; and

WHEREAS, developers of property within the District have already been required to meet the District's groundwater consumption mitigation program; and

NOW, THEREFORE BE IT RESOLVED, by the Board of Directors of the Vandenberg Community Services District that the District reaffirms its policy that it should not allow additional connections which will increase net consumptive demands on the groundwater.
