A RESOLUTION OF THE BOARD OF DIRECTORS OF THE VANDENBERG VILLAGE COMMUNITY SERVICES DISTRICT COMMENDING PHYLLIS WHITE FOR HER SERVICE TO THE RESIDENTS OF VANDENBERG VILLAGE

WHEREAS, Phyllis White was instrumental in the formation of Vandenberg Village Community Services District in 1983 through her work with the Vandenberg Village Association, and she led the successful effort to pass voter-approved bonding and acquire the privately-held Park Water Company Vandenberg Division and form and launch the new Vandenberg Village Community Services District, a local government agency, which took over operations of the water and wastewater systems serving the Village on December 2, 1988, and;

WHEREAS, Phyllis White worked tirelessly and successfully against many odds in the early days of the District converting the private utility to a government agency with limited financial and personnel resources, and when limited staff and Board experience and expertise were available to navigate the new waters of being a public agency. Concurrently, she argued against, and she helped the voters of VVCSD defeat the District's continued State Water Project participation.

WHEREAS, Phyllis White served multiple terms as the Board President, and was consistently requested by staff members to continue service on the Personnel Committee because of her close rapport with all the staff members. She was able to participate in the formulation and approval of all policies, and virtually all decisions, adopted by the District from its formation up until the present time. In this process, she has been a key contributor to the successful maturation of a fledgling District into a seasoned and effective public agency water and wastewater service provider.

WHEREAS, Phyllis White has served selflessly as a representative of the District to numerous outside agencies like the Santa Barbara County Water Purveyors Agency, Santa Barbara County Special Districts Association, and as a Special Districts Commissioner on the County LAFCO Commission, by bringing information from others to the District, and more importantly, casting the VVCSD in a favorable light to other agencies and the general public as a result of her spreading the story of VVCSD's successes to others.
